PROOFS AND CERTIFICATES OF THE CENTRE

Purchase invoice: The basis of the claim settlement is the respective value according to the purchase invoice of the school/rental station (purchase price). The purchase invoice must be sent to SuedwestRing insurance broker.

If the replacement purchase is more expensive due to a price increase by the manufacturer, the purchase/replacement invoice must also be submitted.

If no purchase invoice is submitted despite repeated requests, the settlement will be made:

- Dealer purchase price (Germany) minus 40% discount.
- Date of purchase fictitiously 01 January of the model year

Proof of total loss: The following documents must be sent to SuedwestRing insurance broker.

Photos: a) Single photo per damaged area + photo of the entire unit (sail, board etc.).

b) Material: DIN A4 sized piece of the sail, board etc. with the serial number must be sent.

If the centre is not situated in Germany, please ask the policy holder to carry the required pieces with him back to Germany and send it to SuedwestRing insurance broker.

Transportation cost:

- a) Total damage: Proportionate reimbursement in accordance with the purchase invoice. No reimbursement for (fictitious) individual delivery. Total loss outside the EU: Compensation of an additional lump sum for acquisition of equipment, transport costs, etc. in the amount of 120 €.
- b) Repairable damage: transportation cost to the workshop against proof, provided that the transportation and repair costs together do not exceed the current market value.
